To Whom It May Concern:

Please accept this letter as a summary of services for Raina Goodnight-Ralidak (6/3/2018). I am an associate licensed mental health counselor (MC61294206) under the supervision of Jessica Milian (LF61102102). I have been providing treatment for Raina for (F43.25) Adjustment Disorder, with mixed disturbance of emotions and conduct following significant changes to family structure. I have been working with Raina from 10/14/2024 to present.

**Diagnosis:** (F43.25) Adjustment Disorder, with mixed disturbance of emotions and conduct

**Treatment Goals:**

- Raina will be able to process and identify emotions in a safe environment.
- Raina will be supported in developing self-soothing and coping strategies to help her manage and regulate intense emotions more effectively.
- Raina will be provided with consistent structure and stability by both parents to support her emotional and behavioral development.
- Parents will be mindful of their language and content which Raina is exposed to. Raina will not be burdened with adult concerns and is only exposed to age-appropriate conversations, media, and environments to support her emotional well-being and healthy development.
- Therapy will serve as a safe and supportive environment for Raina, providing consistency and emotional security given the instability she may be experiencing in other areas of her life.

**Overview of Treatment:**

- 22 sessions total
- Raina, Veronika Goodnight (mom), Matthew Ralidak (father), Monica Ralidak (stepmom), Collin Derieg (mom's partner) have all attended at various points.

**Overview of Significant Session Content:**

- **Emotional safety:**
  - Raina reported on 1/20/2025 that mom yelled at her for biting brother.
  - Raina reported on 1/20/2025 that mom and Collin fight "all the time."



- o Raina reported on 1/20/2025 that mom told her that Stepmom is bad and took Dad from her.
- o Raina reported on 2/5/2025 that she misses dad so much but is worried she won't ever see him again. The clinician asked why she was feeling this way and Raina reported she couldn't tell me.
- o Raina reported on 2/13/2025 that mom yells at her and tells her she is bad.
- o Raina asked on 2/17/2025 to not tell mom what she tells the clinician over fear of getting in trouble.
- o Raina reported on 2/17/2025 that she doesn't want to ever leave dad's house and all mom does is yell at her and won't play with her. Raina asked the clinician directly why she has to leave dad's house.
- o Raina reported on 3/3/2025 that mom doesn't play with her the way clinician does, "she never has played with me."
- o Raina reported on 3/17/2025 that she doesn't like Collin but likes Monica, but has to pretend she doesn't when she is with mom.
- o Raina reported on 3/27/2025 that mom had a TV show on that was "scary." Raina asked for her to turn it off because it was scary. Raina stated that "mom ignored me."
- o Raina reported on 4/14/2025 that she misses mom after not being able to see her.
- o Raina reported on 4/14/2025 that she doesn't want to share things in fear it will make mom mad.
- **Physical safety:**
  - o Raina reported on 1/20/2025 that mom grabbed her for biting her brother.
  - o Matthew reported on 1/6/2025 safety concerns that Collin's children had threatened to throw Raina off their balcony.
  - o Raina reported on 2/13/2025 that mom's partner Collin yells at her, tells her to turn around, and spansks her repeatedly.
  - o Raina asked on 2/17/2025 to not tell mom what she tells clinician over fear of getting in trouble.
  - o Raina reported on 3/3/2025 that mom spansks her regularly and spanked her the night before.
  - o Raina reported on 3/17/2025 that again mom spansks her regularly but Collin does not.
  - o On 3/27/2025 Raina had a scheduled appointment that Dad/Stepmom were bringing her to. Upon arrival Raina noticed her mother's car parked in front of the Clinician's office. Raina became emotionally dysregulated and wouldn't come inside the office if mom was present. Raina stated that she was scared to go inside if mom was there. The clinician had to promise mom wasn't in the building, and lock all doors after Raina entered the office.



- o Raina reported on 3/27/2025 that mom is getting an RV with a man that she has to call grandpa. Raina reported that the man tries to hug her but that she doesn't want to be hugged. Raina reported he is "creepy" and "gross." Raina stated the man has tried to kiss her on the lips but told him no. Raina reported he doesn't listen. Raina asked the clinician to not share with mom, because she would get mad.
- o Raina reported on 4/7/2025 that mom had spanked her multiple times and slapped her across the face when wouldn't go to bed.
- **Behaviors of concern:**
  - o Raina on 11/11/2024 during imaginary play asked Clinician to tie her up and kidnap her.
  - o Matthew reported on 1/6/2025 that Raina had made inappropriate and sexually suggestive poses.
  - o Matthew reported on 2/11/2025 that Raina had used a red sharpie to draw blood all over her underwear.
  - o On 3/3/2025 Clinician was approached by mom in the lobby. Mom shared that Raina is sleeping well and repeatedly said she is lying in front of Raina. Raina came into the clinician's office and repeatedly said "All I do is lie," "I am a liar," and "I am not good."
  - o Raina reported on 3/3/2025 that she lied to the clinician about Collin spanking her. Raina reported that it is mom who spansks her regularly. Raina stated that she lied to not make mom mad.

#### **Interventions With Parents:**

- Encouraged parents to provide increased stability and structure for Raina through the establishment of consistent routines. This includes implementing a regular bedtime schedule, a morning routine before school, ensuring timely arrival at school, and creating consistent transition routines. It was recommended that both parents support daily communication by allowing Raina to call the other parent each evening.
  - o Both parents throughout the clinician's time spent with Raina, have remained adamant that they provide this for their child.
  - o Both parents have reported that the other parent does not let Raina make nightly calls.
- Encouraged parents to consistently uphold appropriate boundaries when addressing Raina's unwanted behaviors. Parents were encouraged to enforce these boundaries without resorting to yelling, corporal punishment, or other fear-based disciplinary methods. Encouraged parents to model calm, composed, and controlled responses to guide and support Raina effectively.



- Raina reported on numerous occasions that mom and Collin “always yell” at her.
- Raina reported in 4 sessions that mom used corporal punishment by spanking, grabbing, and slapping her across the face.
- Mom reported directly to the therapist on 4/16/2025 that she had used corporal punishment as a method to get desired behavior. Mom reported that she screamed at Raina that night “to get the fuck out”.
- Encouraged parents to limit Raina’s access to adult related content by filtering adult topics and also by not discussing the other parent in negative or derogatory ways directly with or in the presence of the children.
  - Raina reported she was scared she wouldn’t see her dad again. Raina wouldn’t share with the Clinician why she thought this.
  - Raina reported that she has to pretend to not like Monica to not make her mom mad.
  - The clinician observed mom talk in front of Raina numerous times that Raina was dysregulated and behaving badly “because of her father.”
- Encouraged parents to eliminate access to unsupervised media content.
  - Observed in remote session access through television as Raina put on YouTube with no parental settings. Raina was able to watch any video of her choosing.
  - Raina shared on 3/27/2025 that Mom was watching a scary show called Wednesday. Raina shared she asked mom to turn it off but was ignored.
- Encouraged both parents to take evidence based Positive Parenting Program to support consistency in parenting practices between homes and increase positive parental intervention tools. Course information was provided to both parents by email 2/20/2025.

#### **Overall Response to Parental Interventions:**

- Mom expressed disagreement with the suggested reasoning behind Raina’s behavior. Mom denies any parental challenges while the children are within her care. She reports that she already is providing the recommended support and structure at home. She reports that Raina gets undivided time and connection with her despite Raina’s reports. She reports that she never speaks bad about the father.
- Dad expressed consistent concern and verbal agreement with the need for clinical intervention to support stability between homes. He reports that he actively attempts to make recommended changes in parenting strategies. He reports not speaking negatively about mom in front of the child.

#### **Interventions with Raina:**



- Implemented a structured transition plan when therapy was ending. A consistent routine.
  - Positive
- Implemented increased structure in sessions.
  - Positive
- Implemented a “she chooses, I choose” approach. This gives Raina a choice during a shared activity, followed by the clinician making a choice.
  - Positive
- Implementation of undivided distraction free-time with Raina without the presence of phones or other interruptions.
  - Positive
- These intervention strategies were shared with both parents on 2/18/2025 and encouraged to implement as home due to positive response in therapy.
  - Dad responded by phone and agreed to and verbalized willingness to implement interventions.
  - Mother responded by email and disagreed with the clinical assessment and verbalized a lack of need and willingness to implement interventions.

#### **Clinical Assessment:**

- It is my professional observation that Raina appears to be experiencing significant instability and confusion. The ongoing instability between the home environments seems to be creating a sense of emotional chaos. The reported use of corporal punishment and yelling by her mother might be contributing to her fear and hesitation to express her real feelings. Raina’s behavioral challenges may be a reflection of her deep need for connections and emotional security. Overall, it appears Raina is struggling with feelings of fear, and does not consistently feel safe.

#### **Prognosis:**

- Without improvements in stability and structure across both home environments there is a significant risk that Raina’s maladaptive behaviors will continue to escalate.
- It is my professional assessment that the most effective course of action to improve Raina’s prognosis involves providing her with consistency and stability across both homes. This includes setting and maintaining clear boundaries without the use of fear-based disciplinary practices. It is also essential to Raina that both parents prioritize quality connection time, creating a safe and supportive space where she feels comfortable expressing her true thoughts and emotions. Additionally, careful monitoring of age-appropriate content and ensuring she is surrounded by trusted individuals who contribute to her sense of safety are critical to her overall wellbeing.

To Whom It May Concern:

Please accept this letter as a summary of services for Aidan Goodnight-Ralidak (08/16/2016). I am a licensed Marriage and Family Therapist (LF61611623). I have been providing treatment for Aidan for (F43.25) Adjustment Disorder, with mixed disturbance of emotions and conduct following significant changes to the family structure, and has shown signs of excessive emotional outbursts and problematic school behaviors. I have been working with Aidan from 10/14/2024 to the present.

**Diagnosis:** (F43.25) Adjustment Disorder, with mixed disturbance of emotions and conduct

**Treatment Goals:**

- Be better at listening to instructions from teachers at school and parents at home
- Learn better ways to manage stress

**Overview of Treatment:**

- 16 sessions total
- Aidan, Veronika Goodnight (mom), Matthew Ralidak (father), and Monica Ralidak (stepmom) have all attended at various points.

**Overview of Significant Session Content:**

**Emotional and Physical Safety:**

- Aidan reported on 03/03/2025 that he has been struggling to get much sleep in his room at night because his sister (Raina) keeps him awake.
- Aidan reported on 03/25/2025 that he was struggling with some things at home and not wanting to talk about them for fear of "mom finding out" and getting in trouble. He did share that he was feeling "sad and confused that mom and Collin fight so much" and experiencing some despair and anxiety about being at mom's house, but he did not want to elaborate. Dad also brought him in for therapy.
- Aidan reported on 04/14/2025 that he was sad that he couldn't visit his mom because of the protection order and that he missed her snuggles, but that he did not miss

when she uses her body (pushes or slaps him and his sisters, gets in their physical space/intimidates) or when she says mean things like saying “fuck you” and pointing the middle finger at him and his sisters when she is upset (but she will later try to tell him that she didn't mean it) or telling them when they are crying “don't be a fucking bitch” (which is typically followed by her walking away).

**Clinical Assessment:**

- It is my professional observation that Aidan appears to be experiencing significant emotional and cognitive confusion as a result of an inconsistent home life and observations shared by his mother (as reported by Aidan in multiple sessions, where he identifies being “confused” often about promises made by his mom, and how his mother has changed the way she describes the people in his life). The reported use of corporal punishment and escalated emotional responses had created significant hesitations for Aidan to be willing to express himself or discuss his concerns with others, including professionals. Overall, it appears that Aidan is experiencing emotional distress and doesn't feel consistently secure.

**Prognosis:**

- Without changes to how parenting is approached and without improvements in stability and structure across both home environments, Aidan will continue to escalate the emotional and cognitive insecurity and distress.
- It is my professional assessment that the most effective course of action would include a more consistent home environment and setting healthy boundaries with parents and siblings regarding expressing needs and dealing with conflict. Aidan needs to feel safe expressing his thoughts and emotions with his parents.

During a teletherapy session via phone on 12/20/24, client's father and stepmother reported that the client's mother "has stopped feeding the kids (client and client's two younger siblings) any food at her (client's mother) house and only allows them to drink Purium meal-replacement shakes." Per client's father, on 12/20/24 client had stated that she and her siblings are left alone for dinnertime at client's mother's house. Client's father stated, "Elora (client) is responsible for feeding herself and her siblings, but all she knows how to make is scrambled eggs."

Client's father stated he believes the alleged food restriction at the client's mother's home is not financially related "because I pay her \$1800 per month for child support, but we're pretty sure that money is going directly towards an MLM (multilevel marketing endeavor) that she (client's mother) is involved in." It should be noted that client's father and stepmother have historically expressed some concerns about food scarcity at client's mother's house. Client's father and stepmother state that they currently have concerns with client bingeing and hoarding food when the client is at their home, reporting that these behaviors appear to be heightened when the client has recently returned from her mother's. Client's father also reported that earlier in the week, client's mother "snuck into the kids' (client and her siblings') school cafeteria and berated a lunch lady, trying to limit the foods that are fed to the kids while they're at school."

Therapist spoke with client individually. Client stated, "We just eat a lot of healthy stuff at my mom's house, like cereal." Client was unable to think of any other foods she eats when she is at her mother's home. Client reported her mother continuing to utilize a phone application that "tells us which foods are healthy to eat, so now we can barely eat anything when I'm at my mom's." Client reported feeling "hungry almost every day when I'm there (client's mother's home)."

During a telehealth parent session on 8/2/24, client's father reported that on 7/31/24 client said that River Muggli (client's same-age family friend who engaged in inappropriate sexual behaviors per client's disclosure made on 7/30/24) had been sending the client "really mean, nasty text messages." Client's father also disclosed that client said some of the text messages from River said, "Why did you tell someone our secret? I hate you. We will never be friends again." Client's father reported that client has a cell phone she uses when she is at her mother's house and that the client's mother "lets her (client) use it however she wants."

It should be noted that in May of 2024, the client's father reported that River had been kissing the client "with tongue on multiple occasions." Therapist met with client's mother after this disclosure was made in May, and client's mother expressed doubt that these incidents had occurred because the client "never told me (client's mother) anything about it." At this time, therapist made a recommendation that client and River take a break from contact with each other.

Additionally, at the end of an individual therapy session on 7/30/24, therapist met with client's mother one-on-one to tell her about the client's disclosure during session that day. Therapist reiterated recommendation (originally made in May of 2024) that client does not have contact with River. Client's mother appeared to understand and agree with the recommendation.

Therapist will put clinical recommendation, including detailed stipulations, into a written letter to be sent to both of the client's biological parents.

During the same parent session on 8/2/24, client's father reported that in December of 2023 "Elora (client) said that she was in the car with her mother when an argument broke out between her and her little sister. Elora said that Veronika (client's mother) pulled the car over and smacked Elora across the face." Client's father stated that client reported once they arrived home from this incident, client's mother "went straight into the bathroom, filled up the bathtub, and refused to come out until Elora (client) wrote her (client's mother) a note apologizing for being a bad person." Client's father was unsure whether client's mother allegedly slapping the client left any physical marks or bruises. Clinician made a report to CPS and will send information to law enforcement.

## REPORT FROM SCHOOL:

### CUT AND PASTED NARRATIVE FROM REPORT C25010391

On April 4, 2025, I was dispatched at 1445 hours for a reported DV threats call at Carnation Elementary School, 4950 Tolt Ave.

RP-1 Matthew Ralidak and S-1 Veronika Goodnight are divorced. Ralidak and Goodnight have three children in common, V-1 Raina [REDACTED], O-2 Elora [REDACTED] O-3 Aidan [REDACTED]

O-4 Colin Derieg and Goodnight are currently dating.

O-6 Monica Galarneau and Ralidak are currently married.

O-5 Michelle Frank is the current principal for Carnation Elementary.

Ralidak informed me of the following:

He currently has a tense relationship with Goodnight. They currently share their children 50/50 according to their parenting plan. Ralidak informed me that there is an open CPS case involving Goodnight, a man she is living with, and RGR. Ralidak stated that according to RGR, Goodnight was making her kiss this man. Ralidak did not have any other information about this CPS case.

While waiting, in his car, in line to pick up his children from school. At approximately 1358 hours Goodnight approached Ralidak's car and started yelling at him. Goodnight was accusing Ralidak of calling CPS on her. Goodnight continued yelling and asking Ralidak questions about the children and Goodnight's new living arrangements. At some point Ralidak noticed Derieg standing beside his car staring at him. Goodnight then went into the school office and back out toward Ralidak's car. During this time Ralidak had called into the school's office and told the principal, Frank, and another administrator about the odd behavior and scene Goodnight was making.

Frank then came outside to speak with Goodnight. At approximately 1412 hours Goodnight and Derieg got into a maroon Chevy Silverado and left the school parking lot. Ralidak clarified that no threats were ever made by Goodnight or Derieg. Ralidak stated he felt intimidated by Derieg standing outside his car staring at him. While sharing the details of this incident Ralidak seemed visibly shaken and needed to take breaks, while talking with me, to hold back tears. All three children were not present during this incident.

As I was leaving Ralidak showed me a text from Galarneau, who currently had all three children. Galarneau said that all three children had told her that Goodnight had slapped RGR and slammed her against a wall. Ralidak thought this might be retaliation because RGR had planned to tell Goodnight she no longer wanted to live with her. Ralidak did not mention any marks or bruises on RGR when he had seen her at the school pickup. The text from Galarneau did not describe any injuries on RGR. Ralidak and Galarneau have all three children over the weekend. Ralidak said he is worried for his children's safety and wasn't sure what to do. I gave Ralidak the case number and informed him that he should get in touch with a lawyer and ask about getting a protection order if he is feeling this way.

Frank had informed me of the following:

The office had received a call from Ralidak, so Frank and another administrator had gone outside to see what was going on. Frank spoke with Goodnight and told her "This isn't the place", in reference to not handling parenting issues on school grounds. Frank stated this is not the first time that Goodnight has caused a commotion or interrupted the children's learning process.

Frank then informed me that RGR had told her 1 grade teacher that her mother, Goodnight, had slapped her so hard she was thrown into the wall. Frank stated [REDACTED] was in the process of reporting this incident to CPS.

I reviewed footage taken by Ralidak and the school security footage. The footage showed Goodnight approaching Ralidak's car. Then it looked like Goodnight had started yelling at Ralidak. It then showed Derieg standing a few feet away from the vehicle, staring inside. It did not appear that Derieg or Goodnight made any

threatening gestures. Ralidak remained in his car during the entire incident. There was no audio to the footage.

I sent Ralidak an evidence.com link to upload the footage he has and a screenshot of texts about the slapping incident. Ralidak is also in the process of obtaining the school's security camera footage.

Sequence of Events: Describe the surrounding circumstances that led to the family assessment.

PER MO: MO reported that she does feed her children (showed SW during home walk through food, and doctor's notes to confirm this) and that her children eat 'healthy foods' and that she provides enough food for them along with following doctor's orders (uploaded on famlink). MO reported that all children are up to date on PCP and have been seen at the doctor as they all eat certain foods while they spend time with MO. MO reported that she does not know what they eat when they are with their father (every other week) but that she denies restricting the children's food intake.

SW Pearson contacted MO via phone per additional concerns regarding the children reporting to be uncomfortable with new living situation in a trailer and that their 'grandpa' is making Raina uncomfortable/trying to kiss her on the mouth. SW Pearson explained to MO that these were the concerns along with the unsteady living environment for the children as SW Pearson was told by MO that when MO has the children, they are staying at Collin's home in which SW did a HWT along with interview with no safety concerns. MO reported that she was upset that these allegations were being called in and reported that she was at the school, saying goodbye to her children. MO reported that her bestfriend and another close family friend are where MO is planning on staying with eventually as the commute to the children's school from Collin's home in Monroe is difficult. SW observed that MO was speaking to Collin in the background and SW observed that MO was becoming upset as she reported to have seen FO in the parking line. MO reported to Collin that she may go over there to insist that FO stops calling reports in. SW asked MO who she was speaking to, MO confirmed that it was Collin, and MO reported that she was extremely upset. MO then reported that she knows that FO called in a report and SW Pearson explained that the reporter will remain confidential but if MO is able to provide name/address of where she is living, SW can complete safety assessment to address the concerns. MO reported that she will do this. Then the phone call ended.

PER FO: FO reported that MO does not feed the children and has them on strict diets despite FO taking them to the doctor reporting that there is not a need for a specific diet.

SW Pearson spoke to FO on the phone regarding new concerns about MO having the children stay in a trailer with an unknown person and FO provided their names as 'Jim Solberg and Nathan 'Kanis' Solberg. FO reported that Raina specifically has voiced that these men have tried to kiss her on the mouth and make Raina uncomfortable. FO did not have more information regarding the whereabouts of the Trailer and reported that MO's previous partner, Collin have broken up therefore leading FO to not know where the children are located when the children are in MO's care.

PER COLLIN: Collin reported that the children are on 'special diets' per doctor's orders but that Collin does not have any concerns regarding what the children are eating. Collin reported that MO has these doctor's orders for the children to eat certain foods and then the children go to their FO's home where there are 'no regulations and that Collin reports that there might be a hard time transitioning from households.

PER MONICA: Monica reported that all children have reported that when 'mommy gets out of control' the children must calm there mom down and that they are worried about what will happen when mom gets mad. Monica reported that all children have reported that they get spanked, cursed at, and smacked across the face. Monica reported that Raina therapists have disclosed that MO's now ex-fianc had 'laid hands on the children's. Monica reported that the children have reported that mom and Collin are no longer together. Monica reported that FO had tried to get full custody of the children but that the judge reported that MO is a 'beautiful young woman' which led to 50-50 custody. Monica reported that she is extremely frustrated with the system because FO needs to have at least 50-50 custody and that as of now, Monica and FO are working to document everything to get full-custody of the children.

UNMET NEEDS: Monica reported that the children do not have consistent housing due to MO posting this on social media, and that food has been taken away from the children as punishment. Monica reported that MO

needs MH care/support. Monica reported that MO is not working at this time.

**PER CHILDREN:**

RAINA (6): Raina reported that she gets fed more at her dad's than with her mom.

AIDEN (8): Aiden reported that he feels safe with MO but that he doesn't get as much food with MO as he does with dad because MO says that some foods are not good for him.

ELORA (10): Sometimes Elora reported that she has to cook her own food when she's at her moms, Elora reported that sometimes that she has enough food but sometimes he doesn't.

**PER CHILDREN FOR MOST RECENT INTAKE:**

Aiden reported that MO did hurt Raina (6) but that he didn't want to talk about it. Aiden reported that SW should as Raina.

Elora reported that MO wants to move into an RV and that it is too small. Elora reported that the other adult around but not in the RV with the family is 'Uncle Canny' who is MO's best friend. Elora reported that the RV is on a farm.

SW observed that Raina was not willing to speak with SW as Raina was hiding under her bed and behind Monica and/or FO when SW asked her to speak with her. Raina reported that she only would speak to SW if FO could come with her. SW observed that FO was willing to be with Raina while speaking with SW. SW, FO and Raina went into Raina's room and FO sat on the bed with Raina. SW attempted to ask Raina questions, but she did not want to speak with SW. SW was able to do a body check to see that Raina was free of marks/bruising. Raina did show SW a mark on her chest that was the size of a pencil mark and reported that MO scratched me. Raina was hiding under the covers thus not allowing a full interview to be completed.

**CONVERSATION WITH FO/Monica PER RECENT INTAKE:**

SW spoke to FO outside the home. FO reported that he was upset post Friday (documented in famlink) as MO and Dr. Collin harassed him at school. FO showed SW Pearson the video of Collin making a gun symbol at FO at the school and FO reported to have his legal rep on the phone when SW Pearson arrived as FO is working to document all of this. COLLAT: REPORT FROM SCHOOL: CUT AND PASTED NARRATIVE FROM REPORT C25010391 On April 4, 2025, I was dispatched at 1445 hours for a reported DV threats call at Carnation Elementary School, 4950 Tolt Ave. RP-1 Matthew Ralidak and S-1 Veronika Goodnight are divorced. Ralidak and Goodnight have three children in common, V-1 Raina Goodnight-Ralidak (6 yrs old), O-2 Elora Goodnight-Ralidak (8 yrs old), O-3 Aidan Goodnight-Ralidak (10 yrs old). O-4 Colin Derieg and Goodnight are currently dating. O-6 Monica Galarneau and Ralidak are currently married. O-5 Michelle Frank is the current principal for Carnation Elementary. Ralidak informed me of the following: He currently has a tense relationship with Goodnight. They currently share their children 50/50 according to their parenting plan. Ralidak informed me that there is an open CPS case involving Goodnight, a man she is living with, and RGR. Ralidak stated that according to RGR, Goodnight was making her kiss this man. Ralidak did not have any other information about this CPS case. While waiting, in his car, in line to pick up his children from school. At approximately 1358 hours Goodnight approached Ralidak's car and started yelling at him. Goodnight was accusing Ralidak of calling CPS on her. Goodnight continued yelling and asking Ralidak questions about the children and Goodnight's new living arrangements. At some point Ralidak noticed Derieg standing beside his car staring at him. Goodnight then went into the school office and back out toward Ralidak's car. During this time Ralidak had called into the school's office and told the principal, Frank, and another administrator about the odd behavior and scene Goodnight was making. Frank then came outside to speak with Goodnight. At approximately 1412 hours Goodnight and Derieg got into a maroon Chevy Silverado and left the school parking lot. Ralidak clarified that no threats were ever made by Goodnight or Derieg. Ralidak stated he felt intimidated by Derieg standing outside his car staring at him. While sharing the details of this incident Ralidak seemed visibly shaken and needed to take breaks, while talking with me, to hold back tears. Frank spoke Goodnight and told her "This isn't the place", in reference to not handling parenting issues on school grounds. Frank stated this is not the first time that Goodnight has caused a commotion or interrupted the children's learning process.

**NARRATIVE**

On April 4, 2025, I was dispatched at 1445 hours for a reported DV threats call at Carnation Elementary School, 4950 Told Ave.

RP-1 Matthew Ralidak and S-1 Veronika Goodnight are divorced. Ralidak and Goodnight have three children in common, V-1 Raina Goodnight-Ralidak [REDACTED] O-2 Elora Goodnight-Ralidak [REDACTED] O-3 Aidan Goodnight-Ralidak [REDACTED]

O-4 Colin Derieg and Goodnight are currently dating.

O-6 Monica Galarneau and Ralidak are currently married.

O-5 Michelle Frank is the current principal for Carnation Elementary.

Ralidak informed me of the following:

He currently has a tense relationship with Goodnight. They currently share their children 50/50 according to their parenting plan. Ralidak informed me that there is an open CPS case involving Goodnight, a man she is living with, and RGR. Ralidak stated that according to RGR, Goodnight was making her kiss this man. Ralidak did not have any other information about this CPS case.

While waiting, in his car, in line to pick up his children from school. At approximately 1358 hours Goodnight approached Ralidak's car and started yelling at him. Goodnight was accusing Ralidak of calling CPS on her. Goodnight continued yelling and asking Ralidak questions about the children and Goodnight's new living arrangements. At some point Ralidak noticed Derieg standing beside his car staring at him. Goodnight then went into the school office and back out toward Ralidak's car. During this time Ralidak had called into the school's office and told the principal, Frank, and another administrator about the odd behavior and scene Goodnight was making.

Frank then came outside to speak with Goodnight. At approximately 1412 hours Goodnight and Derieg got into a maroon Chevy Silverado and left the school parking lot. Ralidak clarified that no threats were ever made by Goodnight or Derieg. Ralidak stated he felt intimidated by Derieg standing outside his car staring at him. While sharing the details of this incident Ralidak seemed visibly shaken and needed to take breaks, while talking with me, to hold back tears. All three children were not present during this incident.

As I was leaving Ralidak showed me a text from Galarneau, who currently had all three children. Galarneau said that all three children had told her that Goodnight had slapped RGR and slammed her against a wall. Ralidak thought this might be retaliation because RGR had planned to tell Goodnight she no longer wanted to live with her.

Ralidak did not mention any marks or bruises on RGR when he had seen her at the school pickup. The text from Galarneau did not describe any injuries on RGR. Ralidak and Galarneau have all three children over the weekend.

Ralidak said he is worried for his children's safety and wasn't sure what to do. I gave Ralidak the case number and informed him that he should get in touch with a lawyer and ask about getting a protection order if he is feeling this way.

Frank had informed me of the following:

The office had received a call from Ralidak, so Frank and another administrator had gone outside to see what was going on. Frank spoke with Goodnight and told her "This isn't the place", in reference to not handling parenting issues on school grounds. Frank stated this is not the first time that Goodnight has caused a commotion or interrupted the children's learning process.

Frank then informed me that RGR had told her 1<sup>st</sup> grade teacher that her mother, Goodnight, had slapped her so hard she was thrown into the wall. Frank stated the teacher was in the process of reporting this incident to CPS.

I reviewed footage taken by Ralidak and the school security footage. The footage showed Goodnight approaching Ralidak’s car. Then it looked like Goodnight had started yelling at Ralidak. It then showed Derieg standing a few feet away from the vehicle, staring inside. It did not appear that Derieg or Goodnight made any threatening gestures. Ralidak remained in his car during the entire incident. There was no audio to the footage.

I sent Ralidak an evidence.com link to upload the footage he has and a screenshot of texts about the slapping incident. Ralidak is also in the process of obtaining the school's security camera footage.

Body worn camera was activated and footage uploaded to evidence.com.

I determined there was no crime that occurred between Ralidak and Goodnight.

CPS has been forwarded the case.

I contacted Mathew W. Ralidak (DOB:06/12/1986) with my department cell phone, and he informed me that he had more information to add to the disturbance that occurred at the Elementary school (child pick up line) on 04/04. Ralidak said that upon reviewing the videos that he took of Colin M. Derieg (DOB:01/27/1971), he noticed that Derieg made a hand gesture at his waistline. Ralidak believes that this gesture is supposed to resemble a handgun to threaten Ralidak. Ralidak says he now feels more threatened and intimidated by Derieg. Although Derieg did not say anything or point this gesture at Ralidak, Ralidak believes that Derieg will continue to harass Ralidak but is unsure if these threats are viable.

Ralidak just wants this documented at this time. I advised/reminded Ralidak to petition for a protection order.
