Reply Declaration of Mathew Ralidak

1. I am over 18 years of age and I am the Respondent in this case.
2. I declare:

I am supplementing the therapy notes from two of the children's therapists to include full reports (the previous submissions were summaries only). *See Sealed health docs.* These more in-depth reports reiterate the need for a protection order.

It is concerning that Veronika claims, "I have done nothing to warrant this separation [from the children]..." *Decl. of Pet, p. 2:6-7.* She fails to take responsibility for the pain, trauma, and abuse she inflicted on the children as documented by all three of the children's therapists (see sub #383) which the court found to be "extremely concerning" and 18 calls to CPS by mandatory third-party reporters.

Veronika tries to dismiss my claims against her which were the foundation for the request for a protection order, and properly obtained DVPO, as "false" and "strategic." *Id, p. 2:9.* However, the most compelling information on the abuse of the children and the effect Veronika's manipulative behavior has on them is well documented in the therapy

notes, CPS records, and police reports. None of these reports were made by me or are under my control. These are people whose job it is to protect people, particularly helpless children, from abuse, physical and psychological.

I have attempted to follow the appropriate court procedure for any action I have made in front of the court (parenting plan modification, DVPO, etc.) and Veronika has had an opportunity to be heard every time. She claims litigation abuse when I stand up to protect my children and properly use the court system to accomplish this.

In our 2024 trial, Veronika presented herself to be a caring mother while using social media to garner sympathy from the community and demonize me.

Medical Interference. The statements made by Veronika are misleading and false. Page 9 of the final Parenting Plan (sub #348), grants me the following authority:

Decision-Making Healthcare Provisions.

- Mr. Ralidak may select a medical doctor / pediatrician for the children to see for annual exams, and pursue any course of action recommended by the pediatrician.

I selected Dr. Miller, as the children's pediatrician, who recommended allergy testing for EGR. Veronika obtained the recommendation information from the children's MyChart account and unilaterally scheduled an appointment for EGR. She then notified me of the appointment and threatened to call the authorities if I attended the appointment. See *sub #390, Ex. A*. Contrary to Veronika's statement, Northwest Allergy cancelled the appointment she made until they could review the parenting plan.

She cancelled all three of the children's vaccination appointments although I have express authority to get them vaccinations. Page 10 of the parenting plan states:

Mr. Ralidak may have the children receive all vaccinations recommended by the pediatrician (even over Ms. Goodnight's objection), provided the following is adhered to:

The private and personal health information regarding EGR should have been filed under seal to protect our daughter. *Sub #130, p. 3:16-20*.

I asked to pause the assessment at Dawson for EGR after Veronika unilaterally (ironic since she's falsely accusing me of this) made an appointment for an evaluation

without informing me or obtaining my consent for a very serious concern. I knew nothing about the provider or the evaluation. I wanted to research before allowing the evaluation to move forward. Attached as Exhibit A is a redacted copy of the email I sent regarding the evaluation.

Veronika's misunderstanding of the parenting plan is not a violation on my part.

Information provided by Veronika is outdated and already presented to the court during our 2021 and 2024 trials, which the court considered when drafting our current parenting plan. Dr. Oreskovich's testimony was presented and considered at our 2021 trial, Dr. Bowker's testimony is from our 2024 trial, and the minutes from our 2022 trial, all these have already been considered by the court and do not take into account recent events and information obtained concerning abuse of the children.

The staff at Children's Hospital were unaware during the first class that Veronika attended the class without permission or payment. Due to the protection order, she cannot attend the same class as me and will need to register and pay for her own class. Yes, she has a right to attend classes that she registers and pays for.

The children's therapists decide who, if anyone, can be involved in the therapy sessions. No consent is necessary to obtain records. *Id.*, p. 4:1-3. Therefore, there was no violation of the parenting plan.

As the therapist note indicates, the term "mom" was used by the child when talking to the therapist, I do not encourage or support this moniker.

Allegations of Abuse. The therapy notes speak to numerous statements of Veronika spanking, hitting, and the verbal abuse of the children, over a period of years. This behavior was not an isolated incident. *Id.*, p. 4:19.

Veronika relies on the lack of findings from CPS to claim innocence. This is not a valid conclusion. CPS informed me on 4/9/25 when they came to interview the children, that because there were two households, it becomes a custody issue and there was not enough for CPS to take the children from the mom's home, it would be an issue for family court. The case worker informed me that she would close the CPS case immediately so I could obtain the records for filing in the family law case.

April 4th. Veronika admits to violating the Parenting Plan, section 14, which clearly requires all communication between the parents to go through Talking Parents. *Id.*, p. 5:5-7. The initial police report was filed prior to my submission of the video footage from the school.

March 27th. Concerns about this incident were documented in the therapy notes (see sealed sub #383, p. 5) which are in stark contrast to Veronika's statements. See #390, p. 5:20-23.

Third-Parties. It is curious that these individuals who allegedly care and support our children, only showed up **after** the temporary DVPO was entered. No proof was provided of the alleged "smear campaign." However, Veronika's consistent and overt statements such as, "He's going to hell" (see sub #390, Ex. C, & #384, Ex. B) are well-documented in this case and the DVPO. Veronika has not worked for quite some time. It is doubtful that this case caused her to lose her job. Her unwillingness to work is the primary cause of her being "destitute." Any smearing would only have come from Veronika herself on her social media pages talking about the case, CPS, and issues she has with myself, children's teachers, and others in the community. *Id.* I have never negatively posted on social media about Veronika or sent defamatory emails to her family, friends, or employers but these are all things she has done to me.

Page 7. Exhibit C does not support Veronika's statements. Contrary to Veronika's statements:

False Allegations. Veronika sent me a message via Talking Parent's on 3/1/25 attempting to extort money from me and stated, "the home you sold out under me, and used the money to now live in OUR dream home with your mistress." See sub #384, p. 25. Statements regarding Colin are documented in the children's therapy notes. See sub #383, p. 5. He should not have access to the children's medical records.

It is my understanding, based on my conversations with DCYF on 4/14/25, that 17 CPS reports against Veronika were filed since the parenting plan was entered on 6/25/24, not all in 2025.

DVPO. As stated in my motion and documented via phone records, the children have been calling their mother at least once a day. *See call log attached as Ex. B*. Many times when the children call, she refused to answer or she cuts the calls short, saying she had to go back to work. *See sub #385, TP transcripts*.

Litigation Abuse. Veronika throws out misleading and false statements regarding my taking her to court 28 times when the court docket clearly shows this is a false statement. She has inundated the court with numerous motions and filings. She, again, fails to take accountability for her actions, that she selected and scheduled an appointment for an evaluation of our child at Dawson's Place without notifying or agreement from me. This was a joint decision. I should have the opportunity to conduct a search on any provider, especially when an intensive evaluation is being done, as to what is best for our children.

Ability to Parent. No proof was provided of Veronika's allegations of abuse (litigation, mental, or psychological) because they are untrue.

Fees. There is no basis for Veronika's request for fees, I ask that this be denied. She claims to be "destitute" but paid her attorney \$7,500.

Veronika's other requests are improperly brought before the court, and I ask for those to be denied also.

On Apr 16, 2024, at 8:03 AM, Mathew Ralidak <mralidak@gmail.com> wrote:

Dear Lori Vanderburg and Fran Gatica:

I am writing regarding my daughter, E*** R[REDACTED], age [REDACTED]. Her mother, Veronika Goodnight, sought services from Dawson Place after a situation with a friend, [REDACTED] 2024.

I first found out about Dawson Place when E***'s mother emailed and told me that E*** was scheduled for an assessment. I had no prior knowledge that she was looking into an assessment or that she secured a provider for E***. As Dawson is now aware of, health care (non-emergency) decisions regarding E*** are to be made jointly by Veronika and myself according to the parenting plan signed by the Court. See copy attached. When I pointed out to Veronika that the parenting plan required the decision on E***'s health to be made jointly, she became very upset and accused me of cancelling the appointment. However, in a follow up call with Dawson, it was confirmed that you cancelled the appointment due to the required joint decision-making clause in the parenting plan. There have been several incorrect statements made by Veronika regarding my contact with Dawson. I ask that Dawson utilize email for communication for this case and that both parents, Veronika and I, be included in all communications. This will prevent miscommunication and allow us to focus on meeting E***'s needs. Please let us know who we should be communicating with.

I assume Veronika took time to research the best way to approach discussions, find a provider, and help E*** before contacting Dawson. When I contacted Dawson informing you that I did not give consent for E*** to be assessed at that time, I was merely asking for the same consideration, to be allowed to do my own research before committing her to an assessment. This is not something to be taken lightly and I wanted to make an educated decision regarding matters concerning the health of my daughter.

I did some online research on Dawson but was unable to find specifics on what the two-hour appointment/assessment will entail. Could you please provide Veronika and I with details on how the appointment will go? Will the first appointment be primarily for intake or will E*** be meeting with any providers (mental health, physical exam, therapist etc.)? If yes, will she be expected to meet with the providers individually or will we, her parents, be allowed to go with her?

I anticipate that prior to discussing this sensitive subject with E***, Dawson would interview both parents individually to get the facts from each parent's perspective. I understand that Veronika has already given her point of view to Dawson as she stated to me in an email, "It's all recorded and everyone on this email thread as well as Dawson Place knows your lies." I do not know what she is referring to, but I would like to speak with an intake specialist prior to the May 5th assessment/meeting with E***. Please provide me with a few days and times he or she is available.

I think it is important to note that on the day of the incident, [REDACTED], E*** came home to our house at 3:00 p.m. My wife, Monica, and I were both at home. E*** was there until 5:45 p.m. at which time we got ready for her to go to her mom's house. When

E*** got home, she told us about an injury to her toe and her finger, and that she fell off a scooter and bit her lip while playing. Other than that, during the 2.75 hours she was there, she played, happily drove the tractor around the yard with me, and was generally in an upbeat mood.

Unbeknownst to me, on Tuesday, [REDACTED], 2024, Veronika filed a police report. I was unaware of this until the police contacted me the same day. Then I found out about the appointment Veronika scheduled for E*** with Dawson on March 26th.

I am seeking information and procedure that will assist all of us in providing the best support for E*** and her health and well-being in mind.

Thank you for allowing me to share this with you.
