Dear Jazie, Cassandra, and Gracey,

I am writing to formally follow up on our prior correspondence and request immediate action regarding the conduct of Danielle Smith, LMHCA, at Larch Counseling.

After reviewing Danielle Smith's contact notes and clinical reports, I have grave concerns that:

- Multiple reports made to DCYF were based entirely on hearsay from Mathew Ralidak.
- My daughter Raina's therapeutic disclosures were selectively framed, mischaracterized, and used to alienate me as a parent.
- Ms. Smith did not contact me, nor verify statements, nor operate with any neutrality.
- She admitted to reopening the case through her email on April 6, 2025, based on secondhand information.

This series of missteps has resulted in the complete severance of contact with my daughter for over 47 days, despite a

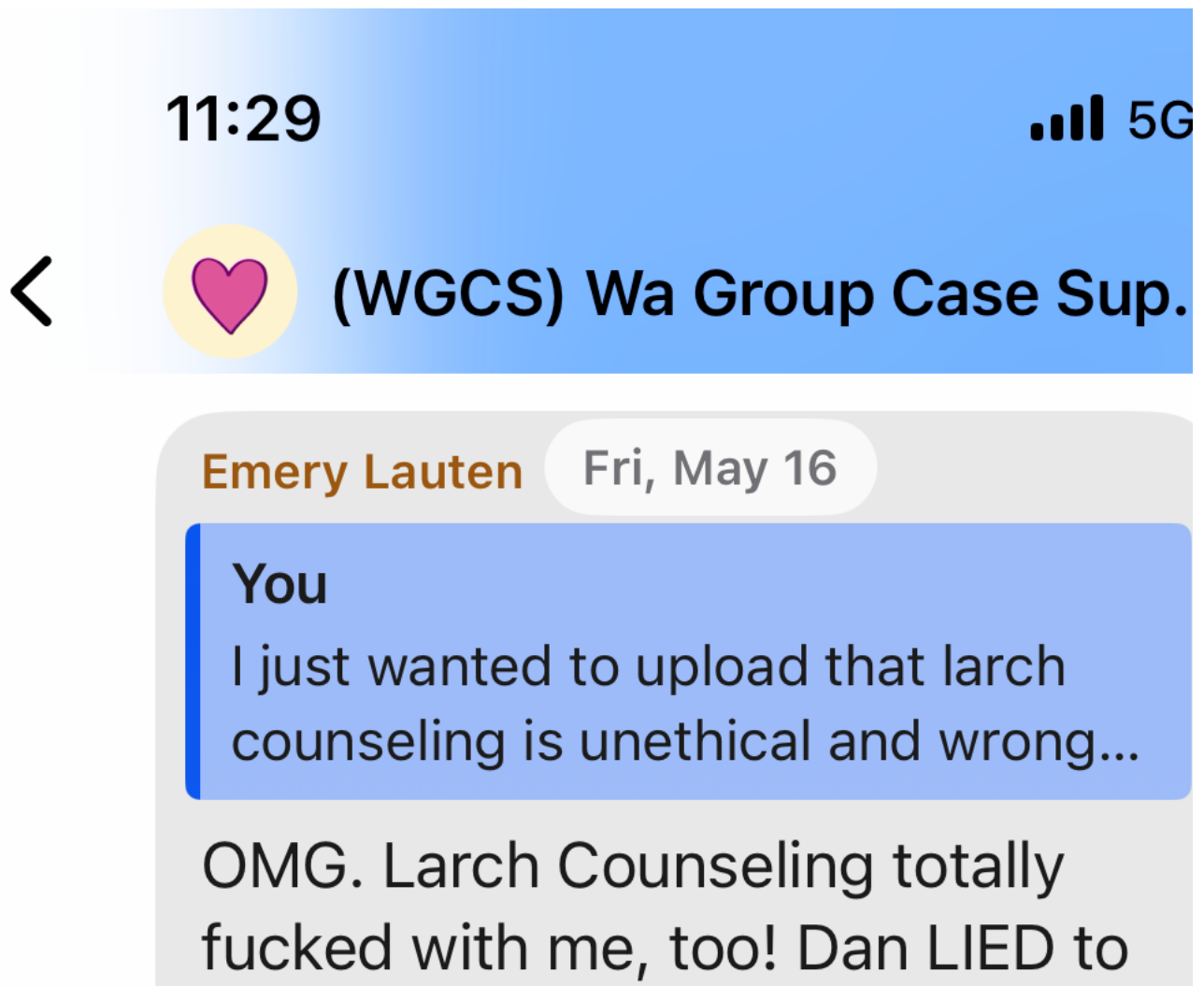
closed CPS case and no findings of abuse. I have extensive declarations and documentation verifying my role as a loving and safe parent, including from medical professionals and school officials.

This is no longer a clinical misjudgment—it is an ethical and legal crisis. I am requesting the following:

1. An official DCYF letter affirming the case closed with no safety concerns or findings of abuse from either Dr. Colin Derieg and my self.
2. An investigation into Danielle Smith's conduct as a mandatory reporter.
3. Coordination with the Department of Health, where I will be filing a formal complaint for professional misconduct.

If DCYF cannot act further, please refer me to the appropriate legal liaison or administrator.

Additionally, I've attached screenshots from another mother, Emery Lauten, who experienced nearly identical misconduct from LARCH Counseling. She alleges she was cut out of her daughter's therapy by counselor Victoria Morgan after her abusive ex intervened. This demonstrates a deeply concerning pattern of behavior by this clinic, which I believe warrants oversight beyond just my individual case.
