**Declaration of Mathew Ralidak**

1. I am over 18 years of age and I am the Respondent in this case.
2. I declare:

**Current Protection/Restraining Order.** I filed my petition for DVPO, King County Case #25-2-11308-6 SEA, on 4/11 after being verbally assaulted and harassed by Veronika and her fiancé on 4/4 while I was trapped in a pick-up car line at our children's school. Later that day, I found out that Veronika had slapped our youngest daughter across the face, shoved her against the door, and spanked her the night before. When the child told her teacher this, the school called CPS.

After obtaining the children's therapy notes, each one has their own therapist, it came to light that physical and emotional abuse had been going on for several years and was documented by all three therapists. More details are in the petition for DVPO which are filed in this case under seal.

The court granted me a three-month DVPO on 4/25/25 after a full hearing under King County Case #25-2-11308-6 SEA. *See copy filed under seal.*

In the order the court stated, the “Protected Party must file a modification order for the family law court to consider.” *Id.*, p. 10. I scheduled an Adequate Cause Hearing in this case for 6/27/25. The court stated it was not making finding regarding parenting but noted that the “allegations and statements in the therapy notes are extremely concerning.” *Id.* A copy of the petition for DVPO, therapy notes, and CPS records are filed with this motion under seal.

**Need for Continued Restraining Order.** Since the protection order was granted, Veronika has violated it at least six times, resulting in cases listed in the chart below. Her violations include numerous calls to me after she was served with the DVPO, as recently as last Friday, 6/8, contacting the children via a third party, her unauthorized attendance at a class that I registered for and waited seven months to be admitted into, and paid for.

Veronika’s abusive behavior has been ongoing for several years. She has approximately 18 CPS intakes from calls regarding her behavior toward the children.

Reasons a protection order is needed:

4/1	Raina wanted to come stay the night with Monica and I after Aidan’s baseball game, saying she did not want to be at Mom’s. Raina stayed the night and I brought Raina to school the morning of April 2nd.
4/2	Raina wanted to come stay the night with Monica and I after Elora’s softball game, saying she did not want to be at Mom’s. Raina stayed the night and I brought Raina to school the morning of April 3rd.
4/3	On the drive to school in the morning Raina told me she didn’t want to live at her mom’s anymore and that she was going to tell her mom that night.
4/4	Incident at the children’s school with Veronika and Colin. In the middle of talking to the sheriff at the school I received a text message from my wife, Moncia, stating that all three kids confirmed that Raina was slapped across the face multiple times, slammed into a door, and beat on the backside the night of the 3rd. This was corroborated in the police report that the principle was told by Raina’s teacher that Raina said she was hit the night before and a history of abuse is noted in the therapy summaries provided by all three of the children’s therapists.
4/7	CPS came to our house to talk to the children. The agent informed me the CPS case would likely be closed and I should request the CPS files to use in family court.
4/11	Granted a temporary DV protection order.
4/16	Raina’s therapist stated: Mom reported directly to the therapist on 4/16/2025 that she had used corporal punishment as a method to get

	desired behavior. Mom reported that she screamed at Raina that night "to get the fuck out".
4/25	Granted DVPO, effective through July 11th, because I must file a motion for PP Mod.
5/7	Contacted police after daily calls from Veronika in violation of the DVPO. The police determined her violations were: 4 FaceTime calls and 8 TP messages. Case #C25013864
5/10	Contacted police after Veronika called my phone on 5/8 in violation of the DVPO. The police determined her violation was: 1 direct phone call. <b>Police Case #C25014244</b>
5/14	Contacted police after Veronika called and sent messages to my secondary phone for the children in violation of the DVPO. The police determined her violation was: 3 direct messages and facetime attempt to a phone I own. <b>Police Case #C25014695</b>
5/15	Veronika unilaterally cancelled Elora's therapy appointments. <i>See true &amp; correct copy of the email attached as Ex. A.</i> Contacted police after Veronika sent me a direct message through Talking Parents app in violation of the DVPO. The police determined her violation was: 1 direct message to my phone. <b>Police Case #C25014822</b>
5/19	Children's therapists said they must pause therapy for the children because Veronika removed her consent. <i>See email from provider filed under seal.</i>
5/20	Informed that Larch Counseling would continue therapy for Aidan and Raina. <i>See email from Larch filed under seal.</i>
5/29	Informed that Compass Health will continue therapy for Elora. <i>See letter from Compass filed under seal.</i>
6/4	Veronika joined, without registering or paying, for a parenting class I signed up for 7 months ago. She accessed my logon information through our son's medical records on MyChart. Violation of 3 <sup>rd</sup> party contact. <b>Police case #C25017058</b>
6/6	Contacted police after Veronika sent a direct messages to my phone via Talking Parents in violation of the DVPO. The police determined her violation was: 1 direct message to my phone. <b>Police Case #C25017335</b>

Email to Danielle, Veronika angry at Raina for sitting on stepmother's lap beat her for it, called Raina manipulative, hit Raina and told her to "get the fuck out"

Although there was a gun surrender in the DVPO case, Father is afraid she still has access to Colin's guns. Her behavior towards the children, in his home, where she has access to firearms.

**Residential Schedule.** Since the DVPO was granted, the children have lived exclusively with the Father and the Mother has phone/video contact only with the children at least once a day. Father asks that this schedule be continued based on the evidence presented

for the DVPO and in this declaration, Mother's continued attempts to manipulate the children, and continued violations of the parenting plan and DVPO, until the parenting plan modification trial. See also the declaration the Father filed in the protection order case. A copy is filed in this case under a family law cover sheet.

Father asks that child support payments be suspended while the children are fully in his care.

**Mother Cancelling Appointments Made by Father.** Father also seeks to restrain Mother from cancelling any doctor's appointments he has the authority to make for the children under the current parenting plan. *Parenting Plan, pages 9-10*. Father specifically has the authority to have the children receive vaccinations. *Id.* Recently, Father scheduled the three children for vaccination appointments on 4/15. Then 15 minutes later, the Mother cancelled all the appointment. The Father also scheduled a 5/7 follow up appointment for the oldest child's stomach issues and when he went to reschedule it for 5/22, the Mother immediately cancelled the appointment. Mother has consistently sabotaged his efforts to obtain medical care and services for the children. He asks the court for an order preventing Mother from cancelling appointments he makes for the children's medical care under the terms of the parenting plan.

The pediatrician recommended that Elora get allergy testing through Northwest Allergy. Mother saw the referral on MyChart and scheduled an appointment with Northwest Allergy without consulting or notifying the Father, who, per the parenting plan, has the authority to schedule all appointments recommended by the children's pediatrician. The court allowed the Father to seek a pediatrician for the children and follow he or her recommendations. *Id.* Since the pediatrician recommended allergy testing and the provider, it was the Father who should have scheduled an appointment with an allergist.

**Use of Talking Parents for Video and Phone Visits.** Father asks for the court to clarify that the calls/video visits with the Mother and Children be through Talking Parents (TP) only. The parties' current parenting plan only allows communication between the parties



via TP. Due to the Mother's manipulation and abuse of the children, it is important that the calls are documented and that a transcript is available if needed for the court.

Since the DVPO was put in place, TP transcripts show the Mother repeatedly asking the children to testify on her behalf at least eight times, to "tell anyone who will listen, teachers, principal, and counselors, about our love, how good our family is, what a good mom I am" and other sentiments. See one example below and TP transcription pages 6, 10, 11, 13, 14, 17, 18, and 20. See *TP transcripts attached as Ex. E*

00:04:21 - Veronika Goodnight - Do you believe I'm a good mom. You're a good kid. I need you to tell whoever will listen how much you love me and miss me. I need you to remember our good life, okay? That will bring us together. All right? And if I. If we don't talk, it's because I'm working and I have no way to call you back. Okay? And I think of you every second of every day, and I just. I miss you. You need to tell everyone who will listen what a good mom I am and how much you miss me and how much you want to be back together. And that's when we'll get back together. Okay? Okay. And keep praying. I keep praying. Every day I give it up to God, and God is going to make us together again. Okay?

The Father has ongoing concerns about the Mother's manipulation of the children and using TP will help monitor this and provide each child's therapist a resource to assist the children.

Mother has claimed on several occasions that she is unable use TP due to weak WiFi. However, when the children were with her in Monroe, they were able to call the Father via cell phone with no issues. Additionally, she informed Father last week, at her unauthorized attendance at his parenting class on 6/4/25, that she obtained new WiFi. She's had successful calls with the children on TP on 4/25, 4/28, 5/18, 5/26, 5/30, 6/1, 6/2, and 6/3.

**Other Requests.** Father asks that Mother not attend the parenting classes regarding ADHD that Father registered for through Children's Hospital, waited 7 months on a waiting list before he was accepted into the class, and which he paid for. The classes were online and the week before the class, each participant who registered received logon information directly via email (see Exhibit B) but because the classes were listed under the child's name, not the parent, the logon information was accessible to the Mother via MyChart. Mother used that information to enter a private, fee-based class without permission. See *Ex. C*. During the class she interrupted the Father and stated at the end, that she would,

see everyone next week. It is inappropriate for the Mother to interject herself into a class paid for by the Father. She is welcome to attend another session that she pays for.

The Father currently has a protection order against the Mother's fiancé, Colin Derieg, King County Case #25-2-11317-5 SEA. Colin was recently added to the children's MyChart account, giving him access to their protected health information. See *Ex. D*. This is not appropriate given the current PO against him. The Father asks that no one who has a protection order against them by either parent, can have access to or be listed in the children's health records or MyChart account.

Father asks the court to grant the requests in motion based the current DVPO, evidence filed in the DVPO case, and this declaration.

Dear Anjali and Dawson Place Staff supervisor,

I am writing to formally notify you that I am withdrawing my consent for any continued therapy services for my daughter, Elora Luna Goodnight-Ralidak (DOB: 03/21/2015), until pending family law proceedings regarding custody, medical decision-making, and access rights are resolved in King County Superior Court.

As a parent with legal joint decision-making authority over Elora's healthcare, I have serious concerns about the current therapeutic environment and the use of therapy records in a manner that has caused significant harm to me and to Elora's continuity of care. Specifically:

- I have been denied any involvement or coordination in Elora's care for over 42 days, in violation of existing court orders.
- I was not consulted about her ongoing participation in sessions or the release of confidential therapeutic notes.
- I have learned that the therapy notes were used against me out of context in a protection order matter initiated under false pretenses.
- Most alarmingly, Elora is reportedly still being taken to the same church where her perpetrator was present — an environment I had previously flagged as unsafe and inappropriate for her healing.

In light of these unresolved legal concerns, I request that all therapy appointments be paused immediately. Please confirm in writing that services have been suspended and that no further sessions or reports will occur without my express consent.

I appreciate the work Dawson Place does in our community and hope this pause can help protect both Elora's mental health and her right to meaningful parental support.

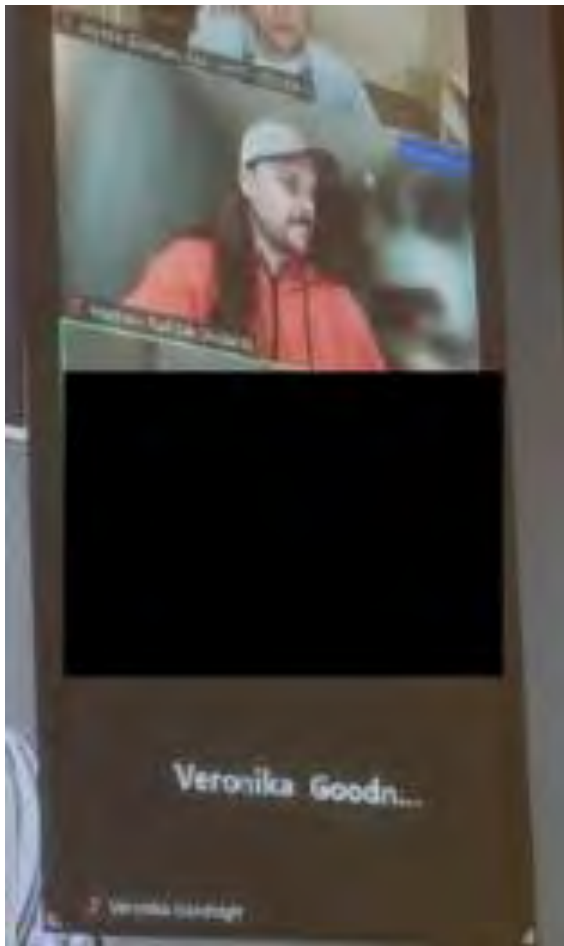
Hi Mathew,

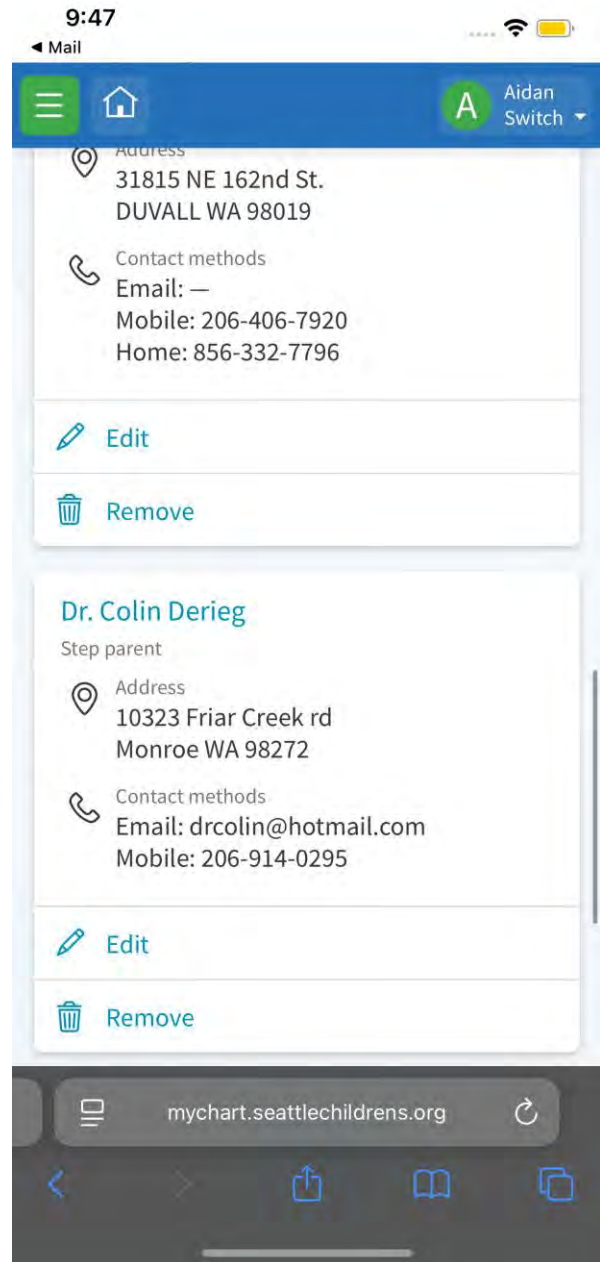
